2023-2024 BUDGET ORDINANCE**

BE IT ORDAINED by the Board of Aldermen of Marshall, North Carolina:

SECTION 1: The following amounts are hereby appropriated in the General Fund for the operation of the town government and its activities for the fiscal year beginning July 01, 2023, and ending June 30, 2024, in accordance with the chart of accounts heretofore established for this Town:

SECTION 3: The following amounts are hereby appropriated in the Enterprise Fund for the operation of the Town’s Water/Sewer System for the fiscal year beginning July 01, 2023 and ending June 30, 2024 in accordance with the chart of accounts heretofore established for this Town.

SECTION 4: It is estimated that the following revenue will be available in the Enterprise Fund for the fiscal year beginning July 01, 2023, and ending June 30, 2024:

SECTION 5: There is hereby levied a tax rate of .49 cents per one hundred dollars (\$ 100.00) Valuation of property listed as of January 01, 2023 for the purpose of raising revenue included in “2023 Ad Valorem Taxes” in the General Fund in Section 2 of this ordinance. This rate is based on as estimated total valuation of property for the purpose of taxation of \$ 124,475,103 and as estimated rate of collection of 96.5%.

SECTION 6: The Finance Officer or designee shall be authorized to transfer appropriations as contained herein under the following conditions:

The Finance Officer or designee shall be authorized to transfer amounts between line items expenditures within a department without limitation and without a report being required. These changes must not result in increases in recurring obligations such as salaries.


SECTION 7: The Finance Officer or designee is hereby restricted from transferring appropriations as contained herein under the following conditions:

- A: The utilization of any contingency appropriation shall be accomplished only with Board authorization.
- B. No salary increase may be made without Board approval.
- C. No new positions/vacancies temporary full-time may be filled without Board approval.

SECTION 8: This ordinance shall be the basis of the financial plans of the Town of Marshall during 2023-2024 Fiscal Year. The Finance Officer or designee shall administer the budget and shall ensure that the operating officials are provided guidance and sufficient detail to implement their appropriate portion of the budget. The accounting section shall establish records which are in consonance with the budget and this ordinance and the appropriate statutes of the State of North Carolina.

SECTION 9: Copies of the Budget Ordinance shall be furnished to the Clerk of the Board of Aldermen and to the Finance Officer or designee to be kept on file by them for their direction in the disbursement of funds.
